**EXECUTIVE ORDER NO.  
RESOLUTION NO. 22E 2021  
LOCAL STATE OF EMERGENCY TO INCLUDE THE IMMINENT THREAT CAUSED BY  
HURRICANE FRED**

**JEFFERSON COUNTY, FL.**

**WHEREAS**, the development of Hurricane Fred poses imminent threat to residents and property located in Jefferson County due to the following conditions: severe weather; very high winds; heavy rain; possible tornadoes and possible flooding; and

**WHEREAS**, Chapter 252.38(3)(a) of the Florida Statutes gives authority to political subdivision to declare and enact a State of Local Emergency for a period of up to seven (7) days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law pertaining to:

1. Performance of public work and taking whatever action is necessary to insure the health, safety and welfare of the community;
2. Entering into contracts;
3. Incurring obligations;
4. Employment of permanent and temporary workers;
5. Utilization of Volunteer workers;
6. Rental of equipment;
7. Acquisition and distribution, with or without compensation, of supplies, materials, and facilities; and
8. The removal of safety hazard trees and debris from private property that has encroached on the public roads and right of way in Jefferson County; and
9. Appropriation and expenditure of public funds; and

Pursuant to this declaration, all procedures and formalities otherwise required of Jefferson County, as listed in items Above, are hereby waived.
