Questions received are provided in black below. Responses to questions are provided in red.

Q1: Is a bid bond required for this ITB?

R1: No.

Q2: How many calendar days do we have to complete this project?

R2: 60 days.

Q3: What are the liquidated damages per day if we do not complete this project on time?

R3: The liquidated damages appear on page 8 of Addendum 1 in the Draft Contract and corresponds to the FDOT Specs 2023-2024 p. 107 for a contract \$299k and under pdf.

Q4: What is the estimated engineer's budget for this project?

R4: \$150,000.00

Q5: Are there any mandatory DBE/minority goal % required to meet to bid on this project?

R5: There is not a mandatory DBE Goal on this project, but the overall aspirational goal for FDOT is 10.65% for Fiscal Years 2021-2023.

Q6: We note that August 7th is a Monday. That means we would have to mail out our bid on Friday August 4th. Is there anyway that this can be moved to later in the week given the letting falls on a Monday?

R6: The County is not extending the deadline for responses.

Q7: On Bid Proposal Form 2 for this tender, it states that the bidder must provide a state contractor's license number. Will the bid be rejected if we do not provide a state contractor's license number? We have the FDOT prequalification for Bridge Repair and Rehabilitation.

R8: A State Contractor's License Number is required on Form 2 for a responsive submittal.
