Q1: What is the estimated construction budget?

A1: The County does not have a set budget. The County Commission has the right to reject all bids if the cost of the courts is too high or not feasible.

Q2: Can I get a copy of the plan holder's list if available?

A2: There is no plan holder's list for this project.

Q3: Do you need to be pre-qualified with Jefferson County?

A3: The minimum qualifications as set by section 3.2 are as follows.

"Responsive Proposers must be registered to do business in Florida and registered with the Florida Department of State Division of Corporations. The Contractor shall possess a State of Florida General or Building Contractor's License and provide copies thereof with the Proposal. The Contractor must have been in business under the Contractor's current company name for a minimum of five (5) years. Proposer must have performed similar work, as the Prime Contractor, for at least one (1) governmental agency (County, City or other Municipality) within the past five (5) years. Proposers that do not meet the meet the minimum qualifications and do not provide the required past project references may be deemed "non-responsive" and/or "non-responsible".

Q4: Will there be a pre-bid site walk meeting?

A4: There are no scheduled pre-bid site meetings, but bidders can inspect the location where the courts will go. The courts will be located at Jefferson County Rec Park at 1380 Mamie Scott Dr, Monticello, FL 32344. The specific location of the court will be the basketball courts located by the four (4) tennis courts. The prospective bidder shall repurpose the current basketball court. This includes expanding the area to meet the specifications detailed in the general specifications to make four (4) pickleball courts.
